(THE TRUST) WAS FORMED FOR THE PURPOSE OF PROMOTING HUMAN NEEDS, THE PRESERVATION, PROTECTION, AND BALANCED USE OF SCENIC, NATURAL, RECREATIONAL, PRODUCTIVE, AND OPEN SPACE LANDS, INCLUDING THE ACQUISITION AND HOLDING OF FEE SIMPLE TITLE, EASEMENTS, AND OTHER REAL PROPERTY INTERESTS. THE TRUST ACQUIRES PROPERTY EASEMENTS EITHER THROUGH DONATIONS IN CONJUNCTION WITH THE MARYLAND ENVIRONMENTAL TRUST OR PURCHASES THROUGH THE MARYLAND RURAL LEGACY PROGRAM. THE TRUST ALSO OWNS AND OPERATES AN EQUESTRIAN CENTER AND STEEPLECHASE COURSE KNOWN AS SHAWAN DOWNS. ACTIONS OF THE ORGANIZATION ARE REGULARLY REVIEWED TO DETERMINE IF THERE IS A POTENTIAL CONFLICT OF INTEREST. WHEN REQUIRED, PROFESSIONAL ADVISORS HAVE BEEN HIRED TO AVOID POTENTIAL CONFLICTS OF INTEREST.

Form 990, Part VI, Section B, Line 15 - THE BOARD, COMPRISED SOLELY OF INDEPENDENT NON-PAID DIRECTORS, NONE OF WHICH HAVE A CONFLICT OF INTEREST WITH RESPECT TO THE COMPENSATION ARRANGEMENT, IS ACCOUNTABLE FOR SETTING REASONABLE COMPENSATION PACKAGES FOR EMPLOYEES. THE BOARD OF DIRECTORS DEVELOPS, CONSISTENT WITH THE ORGANIZATION'S PHILOSOPHY AND PRINCIPLES, THE ANNUAL PERFORMANCE GOALS AND CRITERIA TO BE USED IN DETERMINING MERIT INCREASES AND VARIABLE COMPENSATION CRITERIA FOR THE EMPLOYEES OF LPT. APPROPRIATE COMPARABILITY DATA IS OBTAINED FROM THE INDEPENDENT EXPERTS, I.E., TOTAL ECONOMIC BENEFITS PAID BY SIMILARLY SITUATED ORGANIZATIONS (BOTH TAXABLE AND TAX-EXEMPT) FOR SIMILAR JOB RESPONSIBILITIES. THE BOARD OF DIRECTOR'S WRITTEN RECORDS INCLUDE THE (1) TERMS OF THE ARRANGEMENT WITH THE EMPLOYEE (INCLUDING THE DATE THE ARRANGEMENT WAS APPROVED); (2) A LIST OF MEMBERS PRESENT DURING THE DEBATE ON THE TRANSACTION (AND HOW THE MEMBERS VOTED WHEN IT WAS APPROVED); AND (3) A DESCRIPTION OF THE COMPARABLE DATA RELIED ON BY THE BOARD OF DIRECTORS. KEY DELIBERATIONS OF THE BOARD OF DIRECTORS ARE ALSO DOCUMENTED IN MINUTES WHICH ARE APPROVED AT THE NEXT BOARD OF DIRECTORS MEETING. THE ORGANIZATION DOESN'T HAVE A PAID EXECUTIVE DIRECTOR OR OTHER OFFICER.

Form 990, Part VI, Section C, Line 19 - WHILE FEDERAL TAX LAWS DO NOT MANDATE THAT THE ORGANIZATION'S GOVERNING DOCUMENTS, CONFLICT OF INTEREST POLICY AND FINANCIAL STATEMENTS BE MADE AVAILABLE FOR PUBLIC INSPECTION, THE ORGANIZATION MAKES ITS FINANCIAL STATEMENTS AVAILABLE UPON REQUEST. A PUBLIC INSPECTION COPY OF FORM 990 IS ALSO AVAILABLE UPON REQUEST AT THE ORGANIZATION'S OFFICE.
